Minutes – Regular Meeting

May 27, 2025, 7.30pm

1. **Call to Order:** Meeting called to order by Chairman Frank Pappalardo at 7.30 pm.
2. **Approval of April minutes:** Tabled until next meeting.
3. **Public Comment:** Frank Lishing asked about parking for the new business on Hartford Avenue. There are business spaces in front of the community center, and further down Hartford Avenue.
4. **Correspondence:** Several emails regarding registering golf carts. Explained that everything is on hold until ordinance in place. Karen Camp asked about contacting DEEP for swim lines in front of her house.

Business:

Shoreline Gateway Committee update - Michaelle Pearson: ZEO Eric Knapp said he will take a look at the dumpster in Alley 2, and other issues. RFP no bids. Reformulated and will go out again on Wed. Worked on blight ordinance. Planning to finish our draft next month.

5. **Ordinance Review:** Parking Lots, Swim Area/ Boat Lane, Golf Carts

Town meeting was rescheduled due to overcapacity. Fire Marshal. Will be on Wednesday at 6.30pm at LOLHS. Budget vote and 4 ordinances. Frank Pappalardo reviewed the ordinances:

Golf Carts:

Sound View Commission had a town ordinance Golf Cart permitting program in place that worked well, but the State recently determined that any town that doesn't have an ordinance has to allow golf carts on all roads with a speed limit under 25 mph. SV ordinance was brought into conformance with the State ordinance, and expanded to include some other town roads.

Parking Areas: Ordinance has been in effect since 1985. Open/ close times and days must be posted, Opening must be specified, chained when closed. Attendant on site. Ingress/egress clearly marked. No feather flags.

Swim Area/ Boat Lane: Ropes are in, buoys and signage are being ordered.
