Subject: Devin Berke – Candidate for Regular Member of the Board of Assessment Appeals

Due to the fact that George Finley is not seeking reelection to the Old Lyme Board of Assessment Appeals, the Old Lyme Democratic Town Committee ("DTC") decided to endorse Devin Berke, who is presently an Alternate on the Board, to fill Mr. Finley's seat.

Due to a Connecticut state statute, the two candidates endorsed for regular membership on the Board (Tim Griswold, Republican and Devin Burke, Democrat) will both be elected, regardless of their vote counts.

I am extremely concerned that Mr. Berke will become a regular member of the Board in light of his very poor attendance during the Board's 2025 revaluation appeals process that was conducted last March and April. Of the nine meetings of the Board, Mr. Berke was present for only three. Moreover, of the three meetings he attended, Mr. Berke either arrived late or departed early.

The 2025 Revaluation process involved a physical revaluation of all properties and the Board heard 176 individual appeals. With only three regular members and two alternate members, the Board was indeed handicapped by Mr. Berke's substandard performance. I realize the state statute guarantees Mr. Berke will become a regular member and it is regrettable the DTC endorsed him, knowing about his poor performance.

Personally, I ask Mr. Berke to comment on his performance during the March – April timeframe and to tell the Board members how he will fulfill his duties as the Board prepares for the next appeal process starting in March 2026. If he cannot assure us that he will be an effective member, I suggest that, after the election, he considers resigning his seat.
